Tuition Assistance:

Financial aid at Ambassador Christian Academy is offered to parents/guardians who both agree with our vision and values for a Christ-centered education and have a financial need. Where needed and justified, ACA provides financial aid to allow the largest possible group of students to attend our school. Parents/guardians may apply online for tuition assistance by completing Ambassador Christian Academy application (<https://online.factsmgt.com/signin/3KMPS>). Deadline to Submit application for Financial Aid is April 15th of each year.

FACTS Tuition Management Program:

Ambassador Christian Academy utilizes FACTS Tuition Management Program. FACTS tuition offers a simplified approach to tuition collection. All families will participate in the FACTS tuition program, unless paying tuition in full. If enrolled in FACTS during the 2021/22 school year, you will automatically be re-enrolled for 2022/23 school year. **FACTS has an enrollment fee** (assessed by the FACTS corporation) which will be **automatically deducted 14 days after your receive your confirmation letter from FACTS**, or will be included on your first statement from FACTS.

Delinquent Accounts:

Families with delinquent accounts cannot re-enroll until financial obligations in arrears have been fully satisfied. Tuition accounts must remain current through the end of the year in order to maintain enrollment status. Any account more than 30 days past due are subject to suspension for enrollment for the coming year.

Withdrawn Students:

Families withdrawing from Ambassador Christian Academy must do so in writing indicating last day of school attendance and are responsible for the full month's tuition corresponding to the withdrawal date. A student who withdraws or is dismissed during the school year will be charged a one-month tuition penalty. The student's record will be held until all financial responsibilities have been met.

Before/After Care:

Before care (7:30 – 8:15 am) and aftercare (3:15 – 6:00 pm) are available daily for a per ½ hour charge.
