## 2023-2024 TUITION SCHEDULE

The 10-month payment plan incurs a fee of \$15 per month, for a total annual charge of \$150.

## 2023-2024 FEES

<b>Application Fee: (One-time)</b>	\$175 per student, all grades ( <i>one-time for new students</i> )
<b>Registration Fee: (Every year)</b>	\$250 per student ( <i>Pre-K through 12<sup>th</sup> grade</i> )
<b>Textbooks and Supplies: (Every year)</b>	Pre-K: \$400 per student K-8: \$450 per student 9-12: \$500 per student
<b>Field Trips:</b>	The cost of Field Trips will be incurred by each student as they participate in the trip.

All fees must be paid in full by July 15, 2023 and are non-refundable.

### **TUITION ASSISTANCE**

Financial aid is available to parents and guardians who align with the vision and values of a Christ-centered education and demonstrate financial need. To apply for tuition assistance, parents and guardians can fill out the Ambassador Christian Academy application on the FACTS website ([online.factsmgt.com/signin/3KMPS](https://online.factsmgt.com/signin/3KMPS)). The deadline to submit the financial aid application is April 15, 2023.

### **FACTS TUITION MANAGEMENT PROGRAM**

ACA utilizes the FACTS Tuition Management Program for all families, except for those paying tuition in full. Families who were enrolled in the program during the 2022/23 school year will be automatically re-enrolled for the 2023/24 school year. Note that an enrollment fee, assessed by the FACTS corporation, will be automatically deducted 14 days after receiving a confirmation letter from FACTS or will be included on the first statement.

### **DELINQUENT ACCOUNTS**

Families with unpaid tuition will not be able to re-enroll their children until all outstanding debts have been fully resolved. To maintain enrollment, tuition accounts must be kept up-to-date throughout the year. Accounts that are more than 30 days overdue may result in suspension of enrollment for the current year and/or re-enrollment for the upcoming year. The student's records will not be released until all financial obligations have been fulfilled.

### **WITHDRAWING STUDENTS**

To withdraw a student from ACA, a written notice indicating the final day of attendance must be submitted. The parent or guardian will be responsible for paying the full month's tuition corresponding to the withdrawal date. If a student withdraws or is dismissed during the school year, they will incur a one-month tuition penalty. The student's records will not be released until all financial obligations have been fulfilled.

### **BEFORE/AFTER CARE**

Before care (7:30-8:15am) and after care (3:15-5:00pm) are provided daily at a rate of \$12 per hour.
